

# HARMONIE™ EM 801 Emulsion

### **Product Description**

Harmonie EM 801 contains 52% organic, deodorized Moroccan argan oil. Formulated for damaged hair; Harmonie EM 801 significantly improves dry combing in shampoo and provides excellent wet combing in conditioners. Smoothing is also improved in rinse-off hair products. Softness of hair is improved significantly when compared to neat oil. When incorporated into conditioners, damage repair is possible. Neat argan oil is a deep amber color which can affect the final color of the formulation. Emulsifying argan oil into a white emulsion ensures a much more stable product without affecting the color of the formulation. It can be seen from combing data that adding neat argan oil into shampoo at several active levels actually has a detrimental effect on the condition of the hair. Emulsifying argan oil to ~2µm allows optimum conditioning in rinse-off products. In skin cream, Harmonie EM 801 has shown to maintain homogeneity under shear stress, give a softer initial touch, take less work to spread and give a much more stable product over time when compared to neat argan oil in the same formulation. Skin is also more hydrated when using emulsified argan oil.
