Invisisil SN3001 is a two-component, high elongation silicone gel used for optical bonding applications. This product becomes tack free at room temperature in approximately 30 minutes to a soft, tacky gel with the addition of curing agent. The soft nature and cushioning effect of this product offers excellent protection of electronic assemblies from external humidity, mechanical shock and vibration.
