Processing Recommendations

The amount of antifoam required will be dependent upon the application, however, it is recommended that evaluations begin at 10 ppm of active silicone. While there is no limit to the silicone concentration that may be used in industrial applications, in food grade applications the silicone concentration must not exceed 10 ppm (consult applicable FDA regulations for conditions or limitations of use). Prior to addition to the foaming solution, AF9010E should be gently agitated to insure emulsion uniformity. The AF9010 may then be used as received or may be prediluted with cool water before addition to the foaming solution.

The concentrations of AF9010E required to achieve a silicone level of 10 ppm are listed below:
