

# Niax\* Catalyst LC-5630

## Description

Niax catalyst LC-5630 is unique in its delayed-action capability. It is a thermally activated catalyst that is relatively inert at ambient temperature, but becomes effective at temperatures above 70 °C. At the nominal use level of 2 to 4 parts per hundred parts of Polyol, it typically will cure a typical froth system in about four minutes at 135 to 150 °C. Although used for froth foam technology, Niax Catalyst LC-5630 may find utility in other applications requiring similar catalytic performance.
