

## Niax\* catalyst Potassium Acetate

### Description

Niax catalyst potassium acetate is a low viscosity liquid trimerization catalyst used in the manufacture of rigid polyisocyanurate and polyurethane foams. It is an excellent candidate to consider as a back-end cure catalyst in isocyanurate foams and in general isocyanate reaction products, especially in fast reactivity systems.

Typical product usage level to promote PIR formation is from 1 to 2 php in combination with an appropriate urethane catalyst.

As a cure catalyst in PUR foams, the typical product usage level is 1.3 - 0.5 php.
