### Description

NIAX\* silicone L-6884 is a silicone copolymer for the manufacture of rigid polyurethane foams. Thanks to its versatility, it is an excellent candidate to consider for both continuous and discontinuous applications.

- Extremely fine cells and therefore low thermal conductivity with cyclopentane as well as mixtures of cyclopentane and other hydrocarbons or HFOs
- Good foam flow, even density distribution and reduced voids formation
- The combined effect on fine cells and flow can deliver foams with constantly low thermal conductivities in all areas of the foamed refrigerator cabinet improving the overall potential energy savings
- In foams for the construction industry, Niax silicone L-6884 can provide an additional benefit by improving the fire reaction of the foam and supporting the achievement of positive results in small scale tests
- Typical use level of 2.0 to 3.0 parts per hundred of polyol
