# **Processing Recommendations**

The amount of antifoam required will be dependent upon the application, however, it is recommended that evaluations begin at 10 ppm of active silicone. While there is no limit to the silicone concentration that may be used in industrial applications, in food grade applications the silicone concentration must not exceed 10 ppm (consult applicable FDA regulations for conditions or limitations of use).

The concentrations of AF9020E required to achieve a silicone level of 10 ppm are listed below:
